# Frequently Asked Questions When Interviewing a Real Estate Agent to Help You Buy a Property

#### **Experience & Credentials**

- How long have you been in the Real Estate industry?
- Are you a broker, associate broker, or real estate agent?
- Are you a Realtor (R)?
- If you are new to real estate, will you have a broker or other senior person working with you?
- Are you a full-time or part-time real estate agent?

## **Understanding My Needs**

- I may need closing cost assistance from the seller. Have you negotiated this in the past, and what can I expect?
- Will you take the time to understand my specific needs and preferences?
- Do you specialize in the type of property I am looking for (e.g., single-family homes, condos, investment properties, vacation homes)?
- How do you determine which properties to show me?
- Can you assist me in finding properties that may not be publicly listed?
- I do not want to look at homes above my budget unless you believe that an offer will bring the sales price into my budget area. How do you accomplish this?

## Market Knowledge & Property Search

- Do you have a website connected to MLS that I can sign up for and search?
- How well do you know the neighborhoods I am interested in?
- Can you provide market trends and pricing insights for different areas?
- Do you have access to new listings before they appear online?
- What tools and technology do you use to help me search for homes?
- Can you provide a comparative market analysis (CMA) for homes I am interested in?

## **Negotiation & Making an Offer**

- What is your strategy for negotiating the best price and terms for me?
- How do you handle multiple offer situations?
- What contingencies should I include in my offer?
- If a seller counters my offer, how will you advise me on the next steps?
- Will you help me determine if a seller's asking price is fair?

## **Financing & Costs**

- I am looking for a vacation property that I can rent when I am not there. Can you help me with a property manager and estimates of income?
- Can you recommend mortgage lenders or financial professionals?
- Will you help me understand closing costs and other fees associated with buying a home?
- Do you assist with understanding first-time homebuyer programs, VA loans, or FHA loans?
- How much should I budget for a down payment and additional expenses?

- Can you provide an estimate of what my monthly payments might be for specific properties?

## **Home Inspections & Due Diligence**

- I understand you cannot recommend a home inspector. Can you give me a list of at least three?
- I understand I must pay for the WDIR (termite) report. Can you help me understand it? If there is work to be done, who pays for this?
- Will you help me understand inspection reports and determine what repairs are necessary?
- What should I do if a home inspection reveals major issues?
- Can you assist me in negotiating repairs or seller concessions?
- What other due diligence steps should I take before purchasing a home?

## **Closing Process & Timeline**

- If I cannot be at closing, can you represent me there, collect the keys, and check on the property after closing or before closing?
- How long does it typically take to close on a home?
- What steps are involved in the closing process?
- Will you coordinate with the lender, title company, and other parties?
- Can you provide me with a checklist of tasks I need to complete before closing?
- What could potentially delay closing, and how do we avoid it?

#### **Communication & Availability**

- How will you keep me updated during the home-buying process?
- What is your preferred method of communication (phone, email, text)?
- Are you available on evenings and weekends for showings and questions?
- Will I be working with you directly, or do you have a team?
- How often will you check in with me regarding new listings and updates?

## **Working with Other Professionals**

- Can you refer me to reputable real estate attorneys, lenders, and home inspectors?
- Will you help me find contractors if I want to renovate after purchasing?
- Do you have contacts for insurance providers and home warranty companies?
- If I need a moving company, do you have recommendations?

#### **Buyer Representation & Legal Considerations**

- Will you represent me exclusively as a buyer's agent, or do you also work with sellers?
- Do you require a buyer representation agreement?
- What are my obligations under a buyer's agreement?
- How are you compensated for helping me find a home?
- Can you explain dual agency and whether you engage in it?

## **Post-Purchase Support**

- Will you assist me after closing if I have any issues with the property?
- Can you provide a list of home maintenance professionals that you have used in the past?
- Can you help me understand property taxes and HOA fees?
- What should I do if I want to sell or rent the home in the future?
